ELIGIBILITY REQUIREMENTS

Afghan Hounds, Basenjis, Borzois, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharoah Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis and Whippets that are one year of age or older, that have been registered with The American Kennel Club, or part of an AKC registered litter, or otherwise, if whelped outside of the United States of America and owned by a resident of the USA, or a country with a foreign registry organization whose pedigrees are acceptable for AKC registration and is registered with that registry, or that have been granted an Indefinite Listing Privilege (ILP), are eligible to participate in lure coursing tests and trials and be awarded the prefix title of Field Champion and the suffix titles of Junior Courser, Senior Courser or Master Courser.
Note: Italian Greyhounds are not eligible to compete for Best In Field.

Trial Ribbons: 1st- Blue, 2nd-Red, 3rd-Yellow, 4th-White, 5th-Pink, BOB-Purple and Gold, BIF-Red/White/Blue. Qualifying Test-Dark Green

ALL OWNERS MUST CLEAN UP AFTER THEIR HOUNDS

It is highly recommended that Junior Courser hounds entering the open stake for the first time have successful practice experience with other hounds before competing.

STAKES AND CLASSES OFFERED

OPEN STAKE: Any eligible sighthound that has an ASFA Field Championship, a Canadian Kennel Club Field Championship, AKC Field Championship, or an AKC Courser Suffix (JC).

SPECIAL STAKE: Open to all hounds eligible to enter Open Stake and have earned their AKC Field Championship. No Championship points will be awarded.

OPEN VETERAN: Open to all hounds eligible to enter Open or Special Stakes and meet the age requirement for a veteran as established by the breed parent club. Championship points will be awarded.

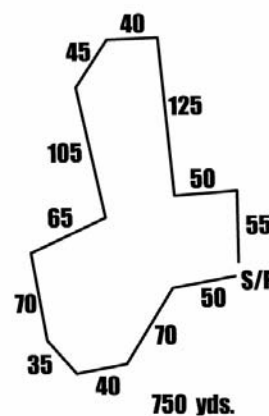
JUNIOR COURSING TEST: JC Test will be offered both days. Open to all eligible sighthounds. A hound running alone shall receive certification from a Judge on one date, and a second certification from a different Judge on a later date, stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption. Ribbons (dark green) will be awarded to all hounds successfully completing the AKC Junior Courser Test.

CONDITIONS OF ENTRY

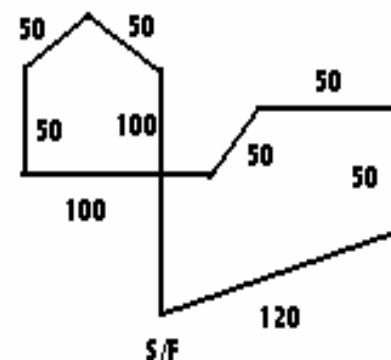
Hounds must be one year of age or older on the day of the trial. All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified. Hounds not present at the time of roll call will be scratched after a 5 minute grace period. Bitches in season and lame hounds will be excused (with entry refunded). All hounds will be examined at inspection for breed disqualifications. Spayed or neutered hounds, without breed disqualifications may be entered. The lure will consist of plastic strips. Only the Lure Operator, Huntmaster, Judges and Handlers of the hounds running in the course in progress will be permitted near the lure machine. The members of the Mid-Atlantic Hound Association reserve the right to alter the course plan as required by weather and/or field conditions on the day of the trial. Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Committee and may be disciplined by the AKC. Children must be under control of their parent(s) or Guardians(s) at all times.

A \$5.00 fine will be assessed on the owner or handler of any hound loose on the field but not competing in the course in progress.

After Hours Veterinarian—Reidsville Veterinary Hospital (336-349-3194) 1401 W. Harrison Street, Reidsville, NC. From Flintlock Trail, turn left on US 158 towards Reidsville and continue for about 9.5 miles to intersection with US 29 (Freeway Drive). Turn left (north) on US 29/US 158 and continue for about 1.5 miles. Turn left on SR 65 (W. Harrison Street) and continue for about 0.5 miles.

MEDICAL EMERGENCY

Moses Cone Memorial Hospital (336-832-7000), 1200 N. Elm Street, Greensboro, NC. From Flintlock Trail, turn right onto US 158 and continue for 5.5 miles to intersection with US 220. Turn left onto US 220 S toward Greensboro. Continue on US 220 for about 12 miles (US 220 becomes Battleground Avenue) until it intersects with Wendell Avenue (US 70/US 220/US 421). Turn east onto Wendell Avenue and continue for about 0.5 miles to the intersection with Elm Street. Turn left on N. Elm Street and continue for about 0.8 miles. The entrance to Moses Cone Memorial Hospital is on the right.
