#### DIRECTIONS TO THE TRIAL

From I 95 North or South, take exit 138 onto US 64 East. Continue on US 64 East approximately 7 miles and exit onto Alternate US 64 East toward Tarboro. From US 64A, turn left at first intersection onto Springfield Road. At first stop sign, turn right onto Leggett Road. Continue 1 mile on Leggett Road until sign for Wishing Well Farm Kennel. Turn into driveway on right.

#### SENIOR COURSER TEST

For the Senior Coursier title, a hound must be eligible to enter the open stake, must run with a least one other hound, and must receive qualifying scores at four AKC trials under two different judges or judging panels. To enter a hound in the Senior Coursier Test, the boxes on the entry form for both "SC Test" and "Open" must be checked. There is no extra entry fee for the SC Test.

It is recommended that Junior Coursier hounds entering the Open Stake for the first time have successful practice experience with other hounds before competing.

##### BEST IN FIELD

A trophy will be awarded to Best in Field winner.

If a hound passes the required second J.C. Test and the owner/handler wishes to enter the subsequent trial, the AKC Coursing Director has granted this club permission to accept trial entries following the test. Entries in this case will be accepted for a period of 15 minutes immediately following the announced finish of the J.C. Test.

**It is recommended that Junior Courser Hounds entering the open stake for the first time have successful practice experience with other hounds before competing.**

**ELIGIBLE BREEDS AND REGISTRY**

Only purebred Afghan Hounds, Basenjis, Borzoi, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Sloughis Scottish Deerhounds, and Whippets that are one year of age or older and have been registered with the American Kennel Club or an American Kennel Club, or part of an AKC registered litter, or otherwise, if whelped outside of the United States of America and owned by a resident of the USA, or a country with a foreign registry organization whose pedigrees are acceptable for AKC registration and is registered with that registry, or that have been granted an Indefinite Listing Privilege (ILP), and sighthounds eligible to compete in the conformation miscellaneous class are eligible to participate in in lure coursing tests and trials and be awarded the prefix title of Field Champion and the suffix titles of Junior Courser, Senior Courser or Master Courser. Hounds may not be entered as "registration pending" or "ILP pending". *Note: Italian Greyhounds are not eligible to compete for Best In Field.*

**RIBBONS**

1st - Blue; 2nd - Red; 3rd - Yellow; 4th - White; 5th - Pink; Best of Breed - Purple and Gold Rosette; Best in Field - Red, White, and Blue Rosette. **Test Ribbon:** Qualifying Course - Dark Green.

**TESTS OFFERED BOTH DAYS**

**JUNIOR COURSER:** Open to all hounds of an eligible breed. A hound running alone shall receive a certification from a Judge on one date, and a second certification from a different Judge on a later date, stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption.

**STAKES OFFERED BOTH DAYS**

**OPEN:** Open to all hounds of an eligible breed that have attained at least one of the following: AKC Junior Courser Title or AKC Field Champion Title. Hounds that are disqualified (or dismissed twice within six trials) from Field Trials may not be entered.

**OPEN VETERAN:** Open to all hounds which are eligible to enter Open or Special stakes and meet the age requirement for a veteran as established by the breed's parent club. Championship points will be awarded.

**SPECIALS:** Open to all hounds that are eligible to enter the Open Stake and have earned their AKC Field Champion Titles. No championship points will be awarded from this stake.

**BEST IN FIELD WILL BE OFFERED BOTH DAYS**

Hounds must be one year of age or older on the day of the trial. All hounds will be run twice, in trios if possible or braces unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused (with entry refund). Hounds not present at the time of roll call will be scratched after a five-minute (5) grace period. Each entry will be examined at inspection for breed disqualifications. Spayed or neutered hounds, without breed disqualifications, may be entered.

Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic strips. Only the Lure Operator, Huntmaster, Judges and Handlers of hounds running in the course in progress will be permitted near the lure machine. The members of the Mid-Atlantic Hound Association reserve the right to alter the course plan as required by weather and/or field conditions on the day of the trial. The field will be reversed for the finals, runoffs, Best of Breed, and Best in Field.

Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Committee and may be disciplined by the AKC. Children must be under control of their parent(s) or guardian(s) at all times.

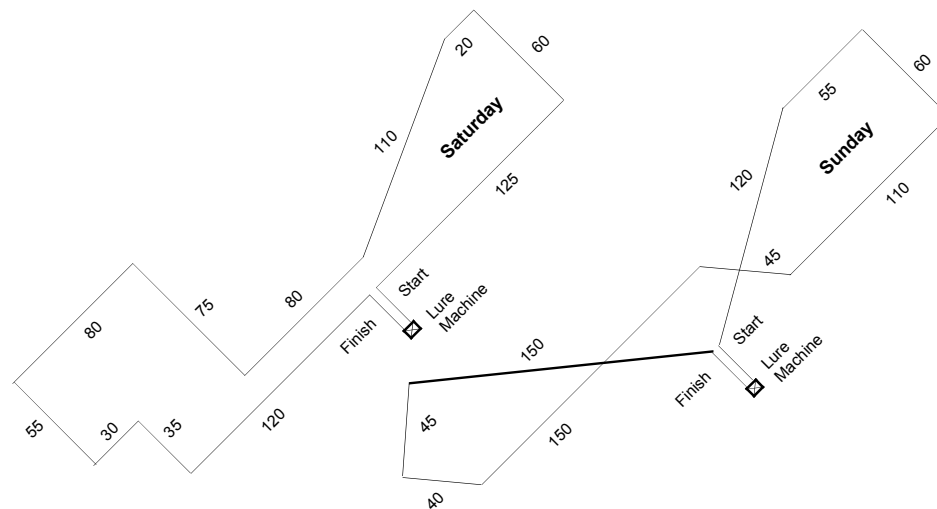
